
The ICGS 2025 conference will be held at the Alliance Manchester Business School (AMBS), located in the heart of The University of Manchester's campus. AMBS offers world-class teaching and research facilities within a modern, purpose-built building.

Initial Double Registration:

The conference will operate a double registration system. Upon arrival at AMBS, delegates must first register at the building's reception desk. 




Floor 3

The Whitworth Hall

An iconic landmark of The University of Manchester, the Whitworth Building is renowned for its grand neo-Gothic architecture and historic Great Hall. Opened in 1902 and named after the industrialist Sir Joseph Whitworth, it stands as a symbol of the University's heritage and academic excellence, hosting prestigious ceremonies, events, and receptions.
