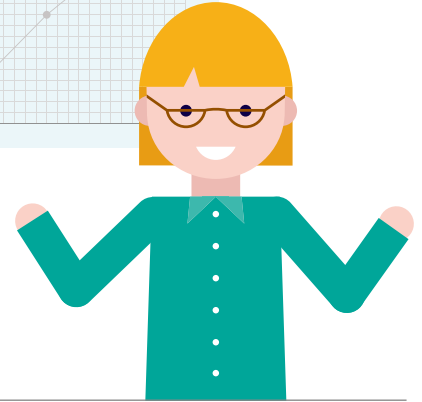
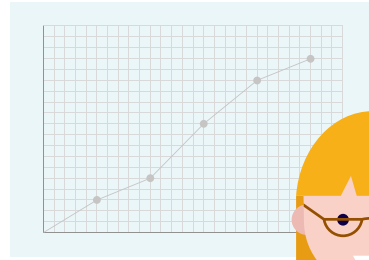


The Flying Start Degree

Scholarships for Business Accounting

In recognition of students passing their first year of this prestigious, but challenging programme, students will be awarded a scholarship in years 2-4. This scholarship will be £7,450 over years 2-4 (£2,483 per year). Both home and international students will be awarded the same amount of scholarship.

In addition to this scholarship, some students may be eligible for the Manchester Bursary, which is awarded to UK students who have had a full financial assessment carried out by Student Finance England.

Scholarships for Social Responsibility

We hope to award a range of Social Responsibility Scholarships to students in 2021. These awards are worth £2,000 per year across three years of study. Applicants should demonstrate a strong commitment to volunteering, charity work, fundraising or community initiatives.

Eligibility criteria: UK/EU and international applicants achieving AAA at A-level (or equivalent)

International Stellar Scholarships

We hope to award a select number of International Stellar Scholarships to talented international students in 2021. These awards are worth £2,000 per year across three years of study.

Year 1

You will spend your first year at University, gaining a strong grounding in the principles of accounting.

You will complete core course units, including Financial Decision making and Financial Reporting, developing your professional skills and preparing you for the workplace. You will take your first examinations that will contribute towards your ACA qualification. You will connect with PwC to decide on your work placement location for second year onwards.

Year 2

Your second year will combine your first work placement at PwC, and studying modules designed to give you a more in-depth understanding of accounting and business strategy.

You will take core course units in accounting, continuing to focus on your ACA qualification. You will study from September until the end of March, developing your analytical skills and knowledge of finance, including a twenty-credit course unit in Tax Principles and Compliance. You will then undertake your first 18-week work placement with real audit clients at PwC, growing your professional network and gaining an insight into the accounting profession.

Year 3

Your third year will also combine work placement and studies, consolidating your expertise in Audit and Assurance and Management Accounting.

You will study until the end of March, when you leave for your second work placement to take on more challenging roles within a client audit environment at PwC. Building on your professional experience, you will apply the knowledge gained on the programme to undertake more complex projects, with greater responsibility. On placement, you will build on key technical skills, helping to fast track your accountancy career. Your studies in this year will help you complete further ICAEW accreditations.

Final year

Your final year includes a research project and a lengthier work placement, designed to prepare you for a graduate career with PwC.

You will continue studying core units in Finance, and in addition you will be able to choose ten credits of optional course units. Your PwC placement will span 19 weeks, taking place from December to May, giving you the chance to put classroom theory into commercial practice. You will also have the opportunity to advance your management skills by coaching junior staff. After your placement you will return to AMBS to complete your research project, and you will qualify for accreditation for all of the Certificate and Professional stage papers in ICAEW's ACA qualification.
